I. The meeting was called to order at 7:00 P.M. by Chairman Don Kropp in our district office located at 1400 West Main Street, Albert Lea, MN.

III. Minutes of the Previous Meeting:

- Minutes of the May 12th regular meeting** were approved as presented on a motion made by Wittmer and seconded by Ausen. Results of a roll call vote were as follows: Affirmative- Kropp, Dahl, Ausen, Heers, Jr., and Wittmer. Opposed -- None. **The motion carried.**

IV. Treasurer's Report:

- The treasurer's balance as of May 31st, 2016**, was \$2,896.98 in checking and \$606,847.13 in savings. A motion approving the treasurer's report as read and payment of bills was made by Heers, Jr. and seconded by Dahl. - Reviewed OBWELL Agreement with DNR for 2016. A motion was made by Ausen and seconded by Wittmer to approve. Results of a roll call vote were as follows: Affirmative- Kropp, Ausen, Heers, Jr. and Wittmer. Opposed – None. **The motion carried.**

V. Cost Share Actions and/or Information:

- Manager Schaetzke announced that Thomas and Betty Jean Collins are requesting final payment for their Grade Stabilization Structure.

- Schaetzke presented drill information and prices- A motion was made by Dahl and seconded by Wittmer to approve the purchase the Great Plains 1206 NT 12' drill. Results of roll call vote were as follows: Affirmative- Kropp, Dahl, Ausen, Heers, Jr., and Wittmer. Opposed -- None. **The motion carried.**
- Schaetzke presented a resolution to support the application to BWSR for One watershed one plan for the Cedar River Watershed. A motion was made by Heers and seconded by Ausen to approve. Results of a roll call vote were as follows: Affirmative- Kropp, Ausen, Heers, Jr. and Wittmer. Opposed – None. **The motion carried.**
- Schaetzke submitted FMLA notice to the board. He requested that the leave be intermittent. A motion was made by Wittmer and seconded by Ausen to approve intermittent leave.
